

Mahalo to all who participated in our recent fundraiser that ran from October thru the end of November. 100% of your generous donations were sent directly to Kapi'olani Children's Miracle Network to help keiki's and their families like the Cabales 'Ohana.

The Cabales is a military family stationed here on O'ahu. When their son Xander was 7 years old, he was taken to the PICU at Kapi'olani after spiking a fever and breaking out in a severe rash all over his body. There he was diagnosed with toxic epidermal necrolysis (TEN), a potentially life-threatening disorder that required care from an entire team of pediatric specialists. Due to the infection, he lost 60 percent of his skin and needed to spend four weeks on life support.



"When I woke up from my coma, I was scared because I couldn't see and I had all of these tubes in my arms, and I was mad because I could no longer move on my own," recalls Xander, now 14 years old.

His health continued to improve, but Xander had to relearn how to hold his head up, sit, walk, talk and eat. After another month of therapy, Xander was able to go home.
